TOURNAMENT RULES AND ENTRY FORM

1. Entrants may be male or female.
2. Entrants **MUST** have a 21 game average from USBC 2015/2016 or 2016/2017 (as of date of tournament) in the local associations (Carson, Greater Reno, Elko, Fallon, Yerington, or Winnemucca) and be currently sanctioned to be eligible for this tournament.

NO EXCEPTIONS.
3. Number of qualifiers will be determined as follows, 16-31 entries = 4 qualifiers, 32-63 entries = 8 qualifiers and 64+ entries = 16 qualifiers maximum.
4. Prize fund will be returned 100%, payouts will be 1 in 4. Prize fund payouts will occur at the conclusion of the tournament.
5. Each entrant will bowl two blocks of 5 games each. Each bowler will move one pair to the right after each game. Each bowler's 10 game total will be used to determine qualifiers for match play. A bowler arriving late will begin play and their score will count beginning with the frame then being bowled.
6. All bowlers will observe a one lane courtesy.
7. Bowlers must check in 30 minutes before 9 a.m. block on Saturday and 30 minutes before 9 a.m. match-play on Sunday.
8. All USBC Rules not mentioned will apply. Tournament Management shall decide any questions not covered by the rules. The decision of Tournament Management will be final unless appealed in accordance to USBC Rule 329.
9. Suitable attire must be worn; tank tops and clothing with obscene language or gestures will not be allowed during tournament play. Final determination of proper attire will be at the discretion of the Tournament Director or their designee. In addition, electronic devices will not be allowed during tournament play.
10. Entrant is responsible for all returned checks. A \$40 collection fee will be charged.
